

BOARD POLICY #001: COMMITTEES

INTRODUCTION

In accordance with the BC Cooperatives Act and the BC Craft Farmers Co-Op (BCCFC) Rules, the elected Board may establish Director and Working Committees to support their work.

BCCFC Rules require the elected Directors to appoint four working committees focused on investment, membership, quality standards and medical access. By resolution, Directors may appoint other committees as needed.

Any committee, in the exercise of the powers delegated to it, must conform to any terms of reference approved by the Directors. The Board may vary, add to or limit the terms of reference of any committee. All Committees strive to make decisions by consensus.

If the Board provide a Director's Committee with authority to exercise power under the Act, the Committee must report every act in the exercise of those powers to the first meeting of the Board after the action.
